An urgent need to reform existing ways of assessing research

- Assessment processes relying predominantly on journal- and publication-based metrics **can be a hurdle to the recognition of diverse contributions and may negatively affect the quality and impact of research.**
- They also contribute to an **unhealthy research culture and an unaffordable publication system.**



From Agreement to action



The Agreement

[The Agreement on Reforming Research](#)
[Assessment](#) sets a **shared direction for changes in assessment practices for research, researchers and research performing organisations.**



Overarching goal

Maximise the **quality and impact of research** by setting a common direction



Scope

The Agreement includes **the principles, commitments and timeframe for reforms** and lays out the **principles for a Coalition** of organisations willing to **work together in implementing the changes.**

CoARA: a shared direction and harmonised lines of action



Brings together all actor groups relevant to the reform, acting as a coalition of doers



Implement the ARRA commitment within an agreed time frame and share progress




Signatories of the Agreement on Reforming Research Assessment (ARRA) do not only advocate for change, they also commit to actively drive reform in research assessment.

4 core commitments

1



Recognise the **diversity of contributions** to, and careers in, research, in accordance with the needs and the nature of the research

2



Base research assessment primarily on **qualitative evaluation** for which **peer-review** is central, supported by **responsible use of quantitative indicators**

3



Abandon the **inappropriate uses** in research assessment of journal- and publication-based **metrics**

4



Avoid the use of **rankings of research** organisations in research assessment

Supporting commitments

5. **Commit resources to reforming research assessment** as is needed to achieve the organisational changes committed to.
6. **Review and develop research assessment criteria, tools and processes.**
7. **Raise awareness** of research assessment reform and **provide transparent communication, guidance, and training** on assessment criteria and processes as well as their use.
8. **Exchange practices and experiences** to enable **mutual learning** within and beyond the Coalition.
9. **Communicate progress** made on adherence to the Principles and implementation of the Commitments.
10. **Evaluate practices, criteria and tools** based on solid evidence and the state-of-the-art in **research on research**, and **make data openly available for evidence gathering and research.**




Action Plans: building blocks for advancing the reform

- Action Plans play a vital role in fulfilling the core commitments of the CoARA Agreement, helping signatories and members outline key milestones for implementing research assessment reform
- Upon signing the Agreement, organisations commit to developing an Action Plan within one year







Cascade Funding: facilitating institutional change


- Support for organisations to **carry out concrete, tangible changes** in research assessment in relevant institutions


Cascade Funding Call 2: facilitating institutional changes




Geographical Diversity of Projects Per Country:








Modernisation of ERC's understanding of excellence – main principles for evaluating a proposed project

- ERC proposals continue to be judged on **excellence** in creativity, originality and potential for significant advances in knowledge (“Ground-breaking nature, ambition and feasibility of the proposal”)
- No structural or procedural changes, but some revisions of terms used:
 - Term high-risk/high-gain no longer used in evaluation question; better terms are ‘ambitious’, ‘creative and original’; not to be misunderstood: ERC continues to encourage risky research!
 - Development of novel methodologies removed from evaluation question: may be positive but not necessary
- More weight on excellence of the project, less weight on PI past achievements (“panels primarily evaluate the excellence of the project”)




Modernisation of ERC's understanding of excellence – main principles for evaluating the applicant

- **No prescriptive Principal Investigator profiles in Work Programme**
- Allowing researchers to provide narrative descriptions of their work (not only stories, but evidence based)
- Room for explaining career breaks or unconventional career paths
- Room for describing contributions that go beyond standard academic duties
- Extramural funding not an evaluation criterion
- Supervision of graduate student or post-docs not an evaluation criterion



ERC Novelties – Research Assessment (as from work programme 2024)

- Evaluation **primarily focused on** the ground-breaking nature, ambition, and feasibility of **the proposed research project**.
- **No numerical scoring of Principal Investigator**, instead an overall assessment of the PI's intellectual capacity and creativity, with a focus on the extent to which the applicant has the required expertise and capacity to successfully execute the project



Draghi/ERA

- Policy harmonisation key for success
- Reform of research assessment is key pillar new ERA framework, precondition for research excellence
- 5th freedom (movement of research, innovation, knowledge) only possible if differences in RA systems per country are minimized (see ARRA)
- Increase in of FP10 budget is to the benefit of a healthy change in research culture. FP10 is backbone of ERA

Key Elements of ERA

- Investment target, national commitment 3% GDP R&D
- Alignment of Policies
- Research Framework improvements
- Safeguarding values




